2. Another of Attar's teachings is that a person lives as long as he lives in this world and he has the power and ability to work, he must work. If a person makes up his mind and works to provide for his life expenses, the world will not be bad for him; because the world is a field where you have to work day and night and plant and benefit from its results.
3. According to Attar, one should rush to work early in the morning in order to receive its blessings, and he emphasizes that everyone should work and be active early in the
